A BILL

for

1 AN ACT relating to motor vehicles; amending county
2 registration fees for vehicles; specifying applicability; and
3 providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 31-3-101(a)(i)(intro), (A) through (C)
8 and (c) and 31-18-401(a)(i) are amended to read:

10 **31-3-101. Registration fees; exemptions.**

11

12 (a) Except as otherwise provided, the following fees
13 shall accompany each application for the registration of a
14 vehicle:

15

1 (i) A county registration fee computed as
2 follows: ~~or five dollars (\$5.00), whichever is greater:~~

3
4 (A) ~~3% of 60% of the factory price plus~~
5 ~~special equipment value~~ One hundred fifty dollars (\$150.00)
6 for a vehicle in its first ~~year~~ through fifth years of
7 service;

8
9 (B) ~~3% of 50% of the factory price plus~~
10 ~~special equipment value~~ Seventy-five dollars (\$75.00) for a
11 vehicle in its ~~second year~~ sixth through tenth years of
12 service;

13
14 (C) ~~3% of 40% of the factory price plus~~
15 ~~special equipment value~~ Fifty dollars (\$50.00) for a vehicle
16 in its ~~third~~ eleventh year of service and thereafter;

17
18 (c) When a factory price or special equipment value is
19 not available ~~for the computation of fees as if~~ required by
20 this act an affidavit of valuation executed by the owner may
21 be accepted. When an affidavit is presented for a homemade
22 trailer or homemade special equipment, an affidavit of
23 valuation executed by the owner may be accepted but the

1 valuation given shall not be less than the actual cost of
2 construction of the trailer or homemade special equipment.
3 The county clerk or treasurer may also ~~utilize~~use a valuation
4 for any trailer set by the county assessor. In no event shall
5 any special equipment for which a registration has been issued
6 be assessed for property taxation purposes pursuant to W.S.
7 39-13-103.

9 **31-18-401. Registration fees.**

11 (a) Except as otherwise provided, the following fees
12 shall accompany each application for the registration of a
13 commercial vehicle:

15 (i) A county registration fee ~~computed in~~
16 ~~accordance with~~as provided in W.S. 31-3-101(a)(i);

18 **Section 2.** W.S. 31-2-103(a)(vii) and 31-3-101(a)(i)(D)
19 through (F) and (iv) are repealed.

21 **Section 3.** This act applies to all registration fees
22 due on and after July 1, 2020 that are subject to
23 W.S. 31-3-101(a)(i).

2 **Section 4.** This act is effective July 1, 2020.
