9 Be It Enacted by the Legislature of the State of Wyoming:

11 Section 1. W.S. 9-4-108 is created to read:

13 9-4-108. Federal funds holding account.

15 There is created the federal funds holding account. All

16 federal funds received by the state of Wyoming which are

not allocated to a specific program or account by state or 1 2 federal law shall be deposited in the federal funds holding 3 Additionally, notwithstanding W.S. 9-4-601, 4 deposits to the federal funds holding account shall include the final year's payment of any congressionally sequestered 5 monies received by the state of Wyoming from the secretary 6 of the treasury of the United States under the provisions 7 8 of the act of congress of February 25, 1920 (41 Stat. 437, 450; 30 U.S.C. §§ 181, 191), as amended, or from lessees or 9 10 authorized mine operators and all monies received by the 11 state from its sale of production from federal mineral 12 leases subject to the act of congress of February 25, 1920 13 (41 Stat. 437, 450; 30 U.S.C. §§ 181, 191), as amended. 14 Funds in the account shall only be disbursed or expended upon an appropriation of the legislature specifically 15 16 referencing an appropriation from the federal funds holding account and shall not be appropriated or authorized for 17 18 disbursement or expenditure pursuant to any other statutory 19 mechanism providing for disbursement of federal funds.

21 **Section 2.** W.S. 9-2-1005(c) by creating new

22 paragraphs (iii) and (iv) and (g) is amended to read:

1 9-2-1005. Payment of warrants; budget powers of governor; agency budgets; federal funds; new employees. 2 3 4 (c) The governor shall not: 5 (iii) Expend or authorize the expenditure of 6 funds from the federal funds holding account absent a 7 <u>legislative</u> appropriation specifically referencing 8 9 appropriation of funds from that account; 10 11 (iv) Expend or authorize the expenditure of 12 federal funds in excess of amounts approved by any 13 legislative appropriations act except in accordance with 14 subsection (g) of this section. 15 16 (g) No federal funds in excess of amounts approved by any legislative appropriations act may be accepted or 17 18 expended until approved by the governor in writing with a 19 copy to the joint appropriations interim committee. If the 20 governor disapproves the acceptance or expenditure of federal funds under this subsection and the federal funds 21 22 are accepted or expended, the state auditor shall not draw 23 any warrant nor shall the state treasurer pay any warrant

which would result in the disbursement of funds, directly 1 2 or indirectly through contracts for services, to the public 3 or private entity involved. The authority under this 4 subsection to expend federal funds shall include only: 5 6 (i) The expenditure of funds allocated to a specific program or account by state or federal law and for 7 which, or from which, the legislature has previously 8 9 appropriated funds in the fiscal biennium in which the 10 funds are accepted; 11 12 (ii) The expenditure of other federal funds if 13 the governor determines the receipt of the federal funds is 14 conditioned upon expenditure of those funds prior to the convening of the next regular general session or budget 15 16 session of the legislature and the expenditure of those 17 federal funds does not create an obligation for the state to expend additional funds. Funds authorized to be 18 expended pursuant to this paragraph shall be reported as 19 20 provided in this subsection and deposited to the federal 21 funds holding account. An amount not in excess of the 22 funds so deposited is appropriated for expenditure from

that account without further legislative action.
