1	AN ACT relating to game and fish; creating the game and
2	fish wildlife round up program; providing for agreements
3	between the game and fish commission and retail businesses
4	for the collection of donations as specified; providing
5	restrictions; providing for rulemaking; creating an
6	account; and providing for an effective date.

8	Be It Enacted by the Legislature of the State of Wyoming:

10	Section 1. W.S. 23-1-505 is created to read:

12	23-1-505. Game and fish wildlife round up program;

There is created the game and fish wildlife round 1 (a) 2 up program where a retail business in this state may enter 3 into an agreement with the commission to provide customers 4 of that retail business a voluntary opportunity to donate 5 funds for wildlife and habitat management and research. The opportunity for donation shall be disclosed at the time 6 a retail purchase is made and in a manner that allows a 7 customer the opportunity to round up the amount of their 8 9 purchase to the next whole dollar or designate the amount 10 of the donation desired. The difference between the purchase price and the next whole dollar amount or the 11 12 amount designated constitutes a donation to the wildlife 13 round up program. No additional amounts for making the 14 donation shall be charged to the customer by the retail 15 business. The commission and the participating business 16 may include in the agreement provisions for retention of a portion of the donated funds by the retail business as an 17 18 administrative fee in an amount not to exceed twenty 19 percent (20%) of the donations collected.

21 (b) The commission may promulgate rules and 22 regulations to implement the program established in 23 subsection (a) of this section.

8	(q) The commission may enter into agreements with
9	retail businesses for the collection of donations for the
10	game and fish wildlife round up program created in W.S.
11	23-1-505. Donations received by the commission pursuant to
12	this paragraph shall be deposited in the wildlife round up
13	account created in W.S. 23-1-501(h).
14	
15	23-1-501. Game and fish fund.
16	
17	(h) An account within the game and fish fund is
18	hereby created as the wildlife round up account. Donations
19	received pursuant to the program created in W.S. 23-1-505
20	shall be credited to the account and are continuously
21	appropriated to the commission for wildlife and habitat
22	management and research.
