2 Section 2. There is appropriated one million eighty-3 one thousand dollars (\$1,081,000.00) from the general fund to 4 the supreme court. This appropriation shall be for the period beginning with the effective date of this act and ending June 5 30, 2020. This appropriation shall only be expended for the 6 7 purpose of implementing the judicial salary increases 8 authorized by this act. Notwithstanding any other provision 9 of law, this appropriation shall not be transferred or 10 expended for any other purpose and any unexpended, 11 unobligated funds remaining from this appropriation shall 12 revert as provided by law on June 30, 2020.

14 Section 3. This act is effective July 1, 2019.
